## **Eligibility Criteria for Scholarship**

Eligibility criteria for the course:

- a. Completion of junior secondary level, which is Grade 9 or an equivalent or above.  
or
- b. Completion of primary education and certified work experience equivalent to a minimum period of two years in a particular field may also be considered as an equivalent qualification for admission to SLQF level 1 provided that the applicant is at least 16 years of age.  
or
- c. Any other relevant qualifications and/or experiences accepted by the Academic Committee of the CSHR and approved by the Faculty Board of the Faculty of Law.  
And
- d. A good working knowledge of the language in which the course will be followed (Sinhala/Tamil/English).

In addition to the above, scholarships are offered to applicants from marginalized communities.
